# **Rules and Regulations**

***The following rules must be adhered to. Any breach of these rules however caused, will result in voiding this agreement or immediate ejection from the venue.***

1. Each food vendor is expected to pay a security deposit of \$200.00; in addition to the cost of the booth space. This deposit will be reimbursed within 48 hours of the day of the event, providing that the vendor did not commit any breach of the agreement.
2. **ALL FOOD VENDORS MUST STOP SELLING AT 9:00P.M. SHARP ON THE SATURDAY & 6:00P.M. ON THE SUNDAY. FAILURE TO COMPLY WILL RESULT IN THE LOSS OF THE SECURITY DEPOSIT AND BANNING FROM FUTURE PARTICIPATION IN JERK FOOD FESTIVAL.**
3. **EACH DAY OF THE FESTIVAL, ALL VENDORS AND THEIR STAFF MUST BE AT THE PARK BETWEEN 6 A.M and 9:30 A.M. SHARP. THE CUT-OFF TIME FOR VENDOR ENTRY IN THE PARK IS 10 A.M. ABSOLUTELY NO ENTRY AFTER 10 A.M.**
4. The Sale of water and pop (juice) are not allowed. Any breach will result in the forfeiture of the security deposit.
5. EACH VENDOR IS RESPONSIBLE FOR CLEANING HIS/HER IMMEDIATE AREA OF ALL GARBAGE THROUGHOUT THE EVENT AND AFTER THE EVENT. GARBAGE SHOULD BE DISPOSED ON IN THE DUMPSTERS ON SITE.
6. EACH VENDOR IS REQUIRED TO PROVIDE HIS/HER OWN STANDBY GENERATOR. Power is available on the premises but reliability cannot be guaranteed.
7. Caribbean Promotions Arts & Culture Inc., or their associates are in no way responsible or will be held liable for personal injury, loss or adversity however caused, as a result of any incident or Act of God on the day of the festival that can be directly or indirectly attributed to any vendor/patron.
8. All booth locations in the park will be pre-assigned and labeled no changes will be accommodated.
9. Until the contract is signed and paid in full, application for vendors' space shall not be a binding contract with Caribbean Promotions Arts & Culture Inc.

## **ON SITE REGULATIONS**

- Vendors may have their company name displayed at the front of their booth. All activities must be conducted within their allotted concession area.
- Caribbean Promotions Arts & Culture Inc. will provide bags to collect garbage generated from sales and all vendors must ensure that their area is restored to its original state free of garbage. Garbage bags may be left on site for disposal.
- Any additional rules imposed by the park on the day must be followed.
- **Vendor's Booth sales are final, and are non-refundable.**
